

Implementation plan

Commitment to establishing a supply chain free from deforestation and illegal conversion of native vegetation

In 2022, the Patense group made an ambitious commitment to eliminate illegal deforestation and conversion of native vegetation in its sustainability policy, aligning it with Brazilian environmental legislation Appointment: (<u>Código Florestal</u>).

Commitment:

"Implementation of a supply chain free from deforestation and illegal conversion of native vegetation, through the traceability of beef and soy embedded in chicken, swine and fish feed, conducting risk analysis and engaging suppliers to the implementation of purchase control mechanisms. Patense considers 2008 as a cut-off date and is committed to implementing a supply chain free of deforestation and illegal conversion of native vegetation by 2040, in accordance with targets set out in the implementation plan"

This implementation plan seeks to build the foundations so that the commitment can be achieved by 2040. In this sense, the actions include mapping and understanding the Patense Group's supply chain, establishing a purchase control system and engaging suppliers to cascade our commitment along the supply chain. In this way, we can better understand the challenges and replan actions over time. In this context, the actions planned for the period 2022-2025 follow the action plan below:

¹ Lines A, B and C correspond to an internal classification of Grupo Patense's suppliers according to the volumes of animal by-products supplied annually. In this way, the lines are dynamic and the suppliers can be reclassified according to the respective volumes supplied.
